

# Drive The Nation™ Traveler Survey Sweepstakes Official Rules

Official Rules and Regulations of this Sweepstakes:

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.

PURCHASE DOES NOT IMPROVE ODDS OF WINNING. VOID WHERE PROHIBITED.

SPONSOR: Travel Guide, LLC d/b/a Travel Media Group. Promotional Period: Entry period begins 9:00 a.m. March 1, 2015 and ends at 12:00 p.m. midnight on March 31, 2015 EST. Entry forms received after 12 midnight on March 31, 2015 will be disqualified. One winner will be selected by a random drawing on or about April 5, 2015.
